Time to rethink the workplace

The Furniture sector is a high material usage sector and, unfortunately, a high material wastage sector as well. With 30,000 tonnes of commercial furniture waste generated in Australia annually, 95% of which ends up in landfill, there is a clear case to rethink the office furniture lifecycle.

At Schiavello, we believe in applying the principles of the circular economy in the workplace. Shifting away from the linear take > make > waste model, towards a more sustainable regenerative loop that designs out waste and keeps resources in use.

It is an approach that goes beyond the traditional commercial view and incorporates environmental and social considerations into the process.

Recycle

At Schiavello, circularity starts with product design. Our furniture is designed with longevity and re-usability in mind – they are 'made to be made again'. Being built to last far beyond their warranties means inherently avoiding further production and the additional outputs that come along with that.

Our design principles of multi-purpose and malleable furniture advocates for the extension of a product's usable life, enabling its re-purposing and re-use.

Data Driven Workplace Management

Our furniture is a product of Australia, with materials sourced locally and products that are designed, manufactured, and assembled locally. As a result, our furniture fundamentally has less embodied carbon, avoiding international transportation which is a significant contributor to greenhouse gas emissions.

Underpinned by a collection of awards, innovations and certifications, sustainability is one of Schiavello's founding principles and remains at the core of everything we do.

Waste Minimisation

Schiavello established a bespoke Environmental Management System certified to ISO 14001:2015 and became a Waste Wise Business in 2001.

Today, our product lifecycle approach works towards the circular economic principles based on a re-use, repurpose, refurbish and recycle hierarchy.

Emissions Reduction

Our commitment to local materials, suppliers and production reduces our carbon footprint and other pollutants simply by never emitting them, in comparison to efforts made to counteract.

Certified to both Greenguard Environmental Institute and the Living Future Institute's Red List Free, we are committed to improving indoor air quality and limiting exposure to chemicals and other pollutants that pose a risk to human health.

95% of our raw materials are locally sourced from iconic Australian brands, including Blue

Scope Steel, Capral (Aluminium), Laminex Industries and Dulux, as well as a variety of SME suppliers.

This means that:

a) emissions are minimised due to the reduced need for international transport, and

b) supply chains are more direct and easier to map, in line with the Modern Slavery Act.

Fair Trade

We have high visibility of everyone at every stage of the production process and ensures fair and ethical treatment to all.

To certify this, we have published our commitment in our Modern Slavery Act and are proud signatories to the ten principles of the UN global Compact.

Social Impact

We work to identify opportunities where products can be donated to communities in need.



Recycling as the last resort

The most sustainable furniture is the one that you don't throw away. Whilst recycling is a better alternative to landfill, to us it is the last resort for office furniture.

At Schiavello, we prioritise the re-use of assets wherever possible. Ultimately what this results in for our partners is:

- Reduced waste
- Maximised value, lifespan, and impact of your assets
- Alignment with stringent sustainability regulations
- Enhanced corporate social image and brand

When workplace assets are re-used, there are significant environmental savings (7-21 times the carbon emissions avoided over even recycling*)



Our workplace asset renewal methodology

We follow a four-step approach to incorporating circular economy practices in the workplace. These four stages of our service can be delivered separately or in tandem, depending on your specific needs and where you are on your workplace asset renewal journey. Schiavello's workplace asset renewal service applies to FF&E across all manufacturers.



Step 1. Project Discovery

A deep dive into your workplace asset strategy, Project Discovery will help us understand your business outcomes.

Identifying what it is that you are seeking to achieve throughout this program, this initial phase will form the building blocks as to how we create your considered methodology and define your critical success factors.

By confirming your needs and scope, together we will create a tailored framework to perform a physical audit of your workplace assets.

Step 2. Audit

With knowledge gained from our Project Discovery phase, we undertake a comprehensive registry of your workplace assets as defined within the scope.

Inspecting and documenting the physical condition of all workplace assets, this is where we begin the early assessment of the next best value of each of your assets.

We will collate information on multiple, critical data points to help you gain an in-depth understanding of what you have, so you can make informed decision on what to do.

Asset tagging and inventory management with Nura Space

The more data organisations have on their assets, the more value they can extract. Unfortunately, when furniture ends up in landfill, so does its data. Nura Space asset tagging allows orgnisations to collect detailed information to support strategic workplace decision making and ESG reporting.

The platform also allows organisations to track the assets throughout their lifecycle, with real-time data that follows the asset at every stage.

- Access accurate, complete data for every item listed in your digital library, including the quantity, condition, location, warranty, photos and more
- Have readily accessible data to instil confidence in your investment recovery initiatives
- Have control over who sees the assets, who can access them and where they end up
- Ditch spreadsheets

Step 4. Project Implementation

With your business direction and criteria confirmed, it is now time to implement your tailored workplace asset renewal strategy.

Delivering a considered approach, built on learnings and insights identified in your previous phases, Schiavello will provide a singular point of accountability to manage and oversee all project expectations. You will receive continuous project updates and a summarised weekly report.
